

Important Program Information


The Rowan-Virtua SOM PA Program is a 24-month program with 12 months of didactic instruction and 12 months of clinical experiences. The PA program has incorporated into its curriculum opportunities for the PA students to meet most US states' requirements for licensure. The PA program does not provide specific CME certificates, but if students choose to do so, they may



complete the assigned state specific training(s) with a state specific CME training program that may incur additional costs to the student(s).
